Directions to Medical Education Research Facility

From I-80 to Health Sciences Campus: Exit I-80 at Coralville's 1st Avenue (exit 242) and travel south one mile. Take a left at stoplight onto US-6/2nd Street and travel toward downtown Iowa City. As you round the corner just past the VA Hospital, you'll find Newton Road. Take a right onto Newton Road and you will enter the UI Health Sciences Campus. The MERF building will be on your left as you come to the top of the hill and round to your left. The Newton Road parking ramp will be on your right and you will proceed beyond the parking ramp to find the entrance for parking. There is an elevator or stairs in the parking ramp and you will cross Newton road and enter the ground floor of MERF.
