# Purpose

Designed for primary care physicians, nurses, social workers, and other healthcare professionals, this conference instructs participants in the diagnosis, treatment, and management of conditions common in older adults. This year's program focuses on a case study based on mental health concerns in geriatrics.

#### Objectives

Upon completion of this program the learner should be able to:

- Discuss the impact of and how to assess depression in older adults.
- Review medication choice and management issues in treating geriatric depression.
- Identify symptoms of Post-Traumatic Stress Disorder (PTSD) and the most effective therapeutic interventions for PTSD in older adults.
- Explore issues around growing older with mental illness.
- Summarize the strengths and areas of need in Iowa's mental health care system.
- Evaluate suicide risk and prevention approaches in older adults.
- List the pros and cons of prescribing anxiolytics to older adults.
- Explain the outpatient medical work-up to differentiate between depression, dementia, and delirium in geriatric patients.
- Identify strategies to improve mental health care for patients in long term care settings.
- Describe the fundamentals of dialectical behavior therapy (DBT).
- Discuss how long term care staff can identify and manage depression in nursing facilities.
