GENERAL INFORMATION

Intended Audience

This course is designed for primary care physicians, physician assistants, nurse practitioners, nurses, certified diabetes educators, and other health care providers.

Purpose

Primary care providers are in best position to educate, to motivate, and manage the health of patients with diabetes. We intend to improve knowledge and competence by discussing issues such as medications, nutrition, and physical activity related to obesity and diabetes.

Educational Objectives

Upon completion of this course the learner should be able to:

- Discuss the regulation of GLP-1 medications on eating behavior.
- Identify and mitigate weight stigma in the healthcare context.
- Review the data supporting use of continuous glucose sensors and automated insulin delivery in enhancing the care of persons with diabetes.
- Review the use of SGLT2 inhibitors in the management of patients with diabetic kidney disease.
- Discuss the clinical presentation and comorbidities of polycystic ovary syndrome.
- Review risk factor for hypoglycemia in older adults and discuss mitigation strategies.
- Discuss the epidemiology, pathophysiology, and current treatment of non-alcoholic fatty liver disease

Registration Fees

The fee is \$180 for physicians, \$130 for nurses and physician assistants, \$100 for other diabetes health care professionals, and \$50 for students/residents. All fees include registration, instruction and educational materials, CME and CEU recording, parking, continental breakfast, refreshment breaks and lunch.




