Purpose

Designed for primary care physicians, nurses, social workers, and other healthcare professionals, this conference instructs participants in the diagnosis, treatment, and management of conditions common in older adults. This year's program focuses on care of the older adult in the nursing facility.

Objectives

- Upon completion of this program the learner should be able to:
- Discuss assessment and management of nursing home residents with sexually inappropriate behavioral disturbances.
- List signs and symptoms of delirium.
- Describe the work-up to differentiate between depression and dementia in the nursing facility population.
- Discuss the complexities of assessing and intervening in suspected mistreatment of a dependent adult.
- Review the components of an effective provider-to-provider phone conversation regarding status changes in facility residents.
- Explore considerations for and the dynamics of stopping medications of uncertain value from the perspectives of patients, families and professional caregivers.
- Summarize diagnostic and treatment challenges pertaining to urinary incontinence and UTIs in nursing facility residents.
- Identify ways to promote infection control in the nursing facility and barriers to implementation.
- Examine quality indicators, quality improvement plans, and systems of reporting in long term care.
- Analyze strategies to improve hand-offs between acute and long-term care facilities.
